

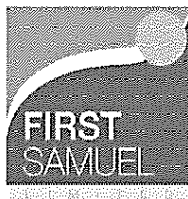

DIRECTIONS


